This is the completion of a multi-year effort in conjunction with the Board for International Professional Standards (BIPS) (now under the Certification Committee of the Professional Development Council) and ICC staff. • Training and Education Work Group

Mission: Recommend ICC Training & Education Programs/Work with Education Committee Members: Sean DeCrane, Group Leader; Scott Adams; Robert Barnett, Rick McCullough, Marc Sampson, Jeff Shapiro.

At its January 29, 2015 conference call, the FSMC voted unanimously to "Request the ICC Board of Directors reconsider its decision to assign each Membership Council one educational slot for the ABM for a cutting-edge/emerging issue topic without the requirements that that program be submitted for review by the Education Committee." The ICC Board did reconsider and voted to maintain the new deadlines. At the March meeting (need date & see minutes of Memphis) the FSMC-GC voted to not submit a class for the future ABM's due to the change in ICC policy.

The February deadline for curriculum submission makes it challenging to arrange training topics that are meaningful to a large number of fire service officials and to obtain instructor commitments.

Building Safety Month and Fire Prevention Month Work Group

Joint meeting of the FSMC and BOMC Governing Committees

The pilot offering of Building & Fire Officials: Working Together to Achieve Public Safety occurred April 17 in Memphis, with 11 participants.

First complete offering will be at the 2015 Annual Business Meeting in Long Beach. It is intended that the 30 students will be equally distributed between fire and building code officials.

FSMC GC member Kelly Nicolello had feature article entitled "Building and Fire Officials Working Together is Focus of New Program" in the August 2015 edition of Building Safety Journal Online.

Solar Issues

The FSMC on April 19 heard a presentation on the partnership between ICC and the Solar Rating & Certification Corporation (SRCC). Eileen Prado, SRCC executive director, Shawn Martin of ICC PMG and John Smirnow, vice president of Trade & Competitiveness for the Solar Energy Industries Association (SEIA) presented the material, including Smirnow's work with fire service

organizations to address concerns with firefighting strategies involving large rooftop photovoltaic solar arrays.

Excellence in Fire and Life Safety Award

Former ICC national fire service director Bruce Johnson on August 27, 2015 was presented the 2015 "Excellence in Fire and Life Safety Award" at the International Association of Fire Chiefs annual Fire Rescue International conference in Atlanta. The Excellence in Fire and Life Safety Award honors those who have dedicated themselves to saving lives and property through the development of codes, fire-prevention practices and leadership techniques. The award is sponsored by the International Code Council (ICC) and the Fire & Life Safety Section (FLSS) of the International Association of Fire Chiefs (IAFC).
