5. Approval of Minutes - May 5, 2022 meeting

Staff reminded the committee and participants about the anti-trust policy.

7. Action Items.

CEPI 214 withdrawn after last meeting.

CEPI-221 Existing building envelope alterations Motion to approve as modified by Helen Sanders. Second by Mike Tillou. Further modified during meeting. Filename: "CEPI-221_Replacement Modification 05-19-2022 as voted.docx"

Approved as modified 12-0-4 (CNV).

Reason: Provides improved clarity and application of existing building envelope alteration requirements with flexibility.

At this point Emily Lorenz chaired the meeting so that Tom Culp could testify on behalf of his interests.

CEPI-16 Pt 1 Door definition Motion to approve as modified by Greg Johnson. Second by Mike Tillou. Approved as modified 16-0-2 (CNV). Reason: To provide consistency between the definitions of fenestration used in the IECC and ASHRAE 90.1. Modification makes sure the air leakage requirement still applies to opaque doors.

CEPI-20 Fenestration ratings Motion to approve as modified by Helen Sanders. Second by Andrea Zani. Vote 6-9-3 (CNV). Failed.

Motion to disapprove by Greg Johnson. Bob Ross seconded. Disapproved 10-5-2 (CNV). Reason: The language lacks clarity in application and will potentially confuse users. It needs better correlation with C407.

CEPI-53 Fenestration U-factors in Group R Motion to disapprove by Greg Johnson. Second by Bob Ross. Disapproved 15-0-3 (CNV). Reason: The proposal does not align with the IECC-R values and provides no cost justification for changes in requirements.

CEPI-54 Orientation requirements (both building form and fenestration) Motion to approve by Helen Sanders. Seconded by Greg Johnson with intent to modify, Greg made a minor modification from "does not exceed" to "is not greater than" in exception 2. Approve with minor editorial modification. 12-2-3 (CNV). Reason: Orientation is proven to be a low cost strategy to save significant energy.

CEPI-167 Toplit daylight zones (approved as-submitted by Lighting, but also referred to Envelope for review)

Discussed. No concerns. Ok with lighting subcommittee moving forward with their recommendation.

CEPI-52 Fenestration U-factors

Proponent asking for feedback. Proponent is looking for more cost data and have not been able to complete their analysis. Suggestion from committee member to look at numbers for operable fenestration too.

Helen Sanders will withdraw this. She needs to send an email to staff.

8. Other business.

Next steps after full committee has completed voting on public comments. Committee ballot on 2nd public comment draft for approximately 30 days and resolution of any comments on that. Schedule dependent on that. Kris will provide more details during the full committee meeting. Public comment draft could potentially be posted from August through October. Perhaps subcommittees will resume again in early November.
