- Identification of Representation / Conflict of Interest (CP#7 Section 5.1.10)

# In part,

- "A committee member shall withdraw from and take no part in those matters with which the committee member has an <u>undisclosed</u> financial, business, or property interest."
- All participants shall "act in an ethical manner, comply with the ethical rules and regulations
  related to his or her profession, and avoid conflicts of interest" and "demonstrate integrity,
  honesty, and fairness while participating in ICC activities."
- It is okay to represent a certain interest, consult, or do work in a certain area that's why you are here, to represent different viewpoints and share your expertise. It just must be disclosed.
- If a proposal overlaps work you do with an employee or clients, disclose it, even if you are not directly representing them on that proposal. Transparency is the key.





- Attend all meetings of your subcommittee (and E4C, for voting members), with few exceptions. You must be present to vote use of proxies is not allowed.
- Abide by ICC Code of Ethics and policy on identifying representation / conflict of interests.
- Be familiar with each proposal, and consider all salient issues and points of view.
- Take on your proportional share of the SC & E4C workload.
- Notify ICC if you change, or are about to change, employers. This will cause your committee appointment to be terminated, although you'll be allowed to reapply from your new position.
- Outside of official committee meetings, do not make public statements as an ICC representative (if someone asks, suggest they talk to Kris).
- Do not share draft documents outside of SC & E4C members tell people that they need to wait until drafts are officially posted by ICC.





- Subcommittee only needs simple majority vote.
- <u>But</u> full committee needs **2/3 vote** to approve proposals and make changes to the draft, so we hope to achieve greater consensus here too.
- Abstentions
  - Abstain if you have an undisclosed conflict (or just don't vote), or if you missed most of the discussion.
  - Don't abstain just because something is contentious or doesn't impact your employee our responsibility is to be familiar with all proposals. Ask questions!
- Provide reason statement for action taken.

We've been assigned 68 proposals as primary subcommittee, and 6 to provide secondary review on envelope aspects.

Rough breakdown of these 74:

- 12 thermal bridging (1 just a comment)
- 14 roof / attic related (4 editorial clean-up)
- 19-21 walls / opaque (5 editorial clean-up)
- 8-10 fenestration (1 editorial clean-up)
- 6 air leakage (1 editorial clean-up) + 1 new topic from full committee
- 13 other (9 editorial clean-up)
