Colorado joins four other states in adopting ICC/MBI Standards 1200/1205

The International Code Council's and Modular Building Institute's (MBI) Standards 1200, 1205 and 1210, as well as *Guideline 6: A Guideline on Advanced Panelization* became effective recently in the state of Colorado. Colorado is the second state to adopt *ICC/MBI 1210 Standard for Mechanical, Electrical and Plumbing Systems, Energy Efficiency and Water Conservation in Off-site Construction* and the first to adopt Guideline 6. The state joins Virginia, Utah, Montana and Rhode Island in adopting ICC/MBI Standards 1200 and 1205 for off-site construction.

'When Disaster Strikes Institutes' trains local officials to plan and respond

The Code Council's **When Disaster Strikes Institute** prepares attendees to plan for, respond to and evaluate damage to our built environment after a disaster. Participants learn the various roles of the fire marshal, code official and floodplain manager in the wake of a disaster, techniques on how to operate within disaster environments, and

how to perform and/or coordinate Initial and Preliminary Damage Assessments, Post-Disaster Building Safety Evaluations, and Substantial Damage Estimating. The Institute also provides a means of maintaining your When Disaster Strikes Certificate of Learning Achievement. The WDS Institute Consists of Six Different Training Programs:

1. Disaster Planning for the Building Department
2. Mutual Aid & DRRR 1206
3. Preliminary Damage Assessment
4. When Disaster Strikes – Evaluator
5. When Disaster Strikes – Coordinator
6. When Disaster Strikes – Refresher

Having a disaster plan and properly trained staff will enable building departments to rapidly and accurately perform initial and preliminary damage assessments, commence post-disaster building safety evaluations, and efficiently deal with increased permit intake, plans review and accompanying construction inspections. Clark County, Washington, is leading the nation on using virtual inspections

Before the COVID-19 pandemic, few considered the idea of virtual inspections. It seemed like a foreign concept for an industry that had developed and established a successful set of procedures to ensure the safety and compliance of new building construction, modifications, and renovations. But long before stay-at-home orders and social distancing became the norm, Jim Muir, former Building Official for [Clark County, Washington](#), saw the potential in conducting inspections virtually. The idea came about when one of his inspectors, Boyd, was diagnosed with a brain tumor in 2012. Boyd was an incredibly dedicated inspector and wanted to continue working while on light duty, so Muir suggested that he remain in the office and conduct re-inspections over FaceTime video calls. There were some initial objections, but Muir wasn't deterred. He pushed for solutions to every possible obstacle and was determined to give Htry his best to make it work.

LaPorte, Texas, adopts the 2024 I-Codes to advance building safety

The City Council of La Porte, Texas, demonstrated its commitment to advancing building safety and enhancing community resilience by voting to adopt the International Code Council's [2024 International Codes®](#) (I-Codes).

This move includes the adoption of the:

- [International Swimming Pool and Spa Code®](#)

Notably, for the first time, La Porte is also adopting the [International Property Maintenance Code®](#) and the [International Existing Building Code®](#) (IEBC).

"The La Porte City Council has proactively advanced building safety by upgrading from the 2018 I-Codes to the 2024 I-Codes, reaffirming the city's commitment to adopting the latest construction and safety standards," said Assistant City Manager Matt Daeumer.

CALL FOR COMMITTEE: ICC 825, Private Sewage Disposal Systems

The International Code Council is currently seeking additional contractors, engineers, code officials, academics, manufacturers, health authority experts and other industry stakeholders to volunteer for a Code Council committee to assist in the progress of a standard currently in development. This committee has primary responsibility for the development of the global standard, ICC 825, Private Sewage Disposal Systems, which will provide minimum requirements for designing, constructing, operating and maintaining private sewage disposal systems that include septic tank and effluent absorption systems, or other treatment tank and effluent disposal systems, where a public sewer is not available.

ICC Plumbing, Mechanical, and Fuel Gas Updates

Program institutes regulations to maximize the reclamation of HFCs

December 10, 2024, marked the beginning of the [U.S. Environmental Protection Agency's](#) (EPA) [Emissions Reduction and Reclamation \(ER&R\) Program](#) for some hydrofluorocarbon (HFC) refrigerants and their substitutes. The ER&R program is the latest in a series of programs that the EPA has enacted under the authority of the American Innovation and Manufacturing Act of 2020 (AIM Act) to handle HFC refrigerants. This program institutes regulations to maximize the reclamation of HFCs and their substitutes having a GWP (global warming potential) above certain limits; it also intends to minimize the release of HFCs from certain equipment. The program encompasses not only the refrigeration, air conditioning and heat pumps sectors but also the fire suppression sector.

MEMO TO ICC MEMBERS: Navigating Current Federal Grants Policies

On January 27 and 28, the federal Office of Management and Budget (OMB) issued a memo and [follow up guidance](#) pausing federal financial assistance while OMB works to ensure that future disbursements are consistent with the policies articulated in Executive Orders President Trump issued during his first days in office.

These Executive Orders include those reversing Biden Administration policies on diversity, equity and inclusion; environmental justice; electrification and electric vehicles incentives; and appliance efficiency standards.

These actions put an immediate pause on grant funding through the Department of Energy's (DOE) Resilience and Efficient Codes Initiative (RECI) and Assistance for the Adoption of the Latest and Zero Building Energy Codes program. OMB issued a subsequent memo on January 29, rescinding its prior federal funding freeze guidance; this latest action does not affect the DOE programs, which were directly addressed in an [Executive Order](#). On January 31, the U.S. District Court of Rhode Island issued a Temporary Restraining Order that prohibits federal agencies from taking actions on funding programs on the basis of the Executive Orders of OMB memos.

Agencies may still withhold funding, but they may only do so pursuant to their existing authorities. Implications for existing and pending awards are uncertain and will vary depending on the issuing authority.

The Building Resilient Infrastructure and Communities (BRIC) Program

As of this writing, the effect on disbursement of the Federal Emergency Management Agency's (FEMA) Fiscal Year 2023 Building Resilient Infrastructure and Communities (BRIC) awards and the currently open Notice of Funding Opportunity for Fiscal Year 2024 BRIC funding is unclear.

The BRIC program, which was established and implemented during President Trump's first term, continues to be a significant opportunity for communities to secure resources for resilience, building safety and the advancement of modern, hazard-resistant building codes.

While the BRIC program will continue to evolve with the current Administration's priorities, it is important that states, tribes, territories, counties and jurisdictions that are considering applying for BRIC continue [preparing your application](#) so that it is ready for submittal:

1. Continue gathering documentation, preparing applications and meeting state deadlines associated with the FY24 BRIC NOFO.
2. Reach out to your State Hazard Mitigation Officer for guidance or clarification as needed regarding deadlines and state specific reviews.
3. Stay connected with the International Code Council for updates—we are committed to keeping you informed.

The Code Council will continue to support you in your efforts as we work with the Trump Administration on the best paths forward.
