4) Review and Approval of the Agenda

No changes suggested. Motion made and seconded for accepting Agenda as-is. Approved unanimously.

B. ASABE/ICC 802 PROPOSALS, REVIEW AND DISCUSSION

- 1) Review of Proposals
 - a. Review and discuss Public Input Agenda (Proposals)

IS-IEDC 01-01-18 and 01-02-18 (both by Stephenson)

Members agreed that there needs to be commonality of defintions between other standards and codes to avoid conflicts. A workgroup is needed for the definitions in these proposals and perhaps other related definitions.

IS-IEDC 01-03-18 and 01-04-18 (both by Tanner)

Members agreed that validation of test methods is possible and that a workgroup is needed to examine/develop validation test methods.

b. Discuss any Committee member ideas

Malooly introduced presented two verbal items:

1) Produce the label legible to technical people and consumers.

Members agreed that this is important and should be looked into by a workgroup.

2) Drip/Micro-irrigation tubing sizes need to be standardized.

Randy Pearson (The Toro Company) discussed the far-reaching implications, supported by Kelsey Jacquard (Hunter Industries).

Perhaps a workgroup could be formed to explore how standardization could be implemented for editions of the standard beyond this next edition.

Pike introduced and discussed one written item.

1) Document: "Suggested ASABE/ICC-802 Spray Sprinkler Body Test Method Revisions (October 9, 2018)"

Members agreed that this was valuable for a working group to use.

2) Establish Work Groups.

Aittaniemi informed the members that each workgroup needs to have a brief scoping statement that focuses the work group. Preferably, work group scoping statements would be developed today in this meeting.

Aittaniemi informed the members that each workgroup needs to have a Chair and the Chair can be anyone (doesn't have to be a Committee member.) Selection of a Vice Chair is optional.

Motion made and seconded for forming a work group on Definitions. Approved unanimously.

Motion made and seconded for forming a work group on Testing Methods. Approved unanimously. Motion made and seconded for assigning Pike's document "Suggested ASABE/ICC-802 Spray Sprinkler Body Test Method Revisions (October 9, 2018)" to this workgroup to use. Approved unanimously.

Motion made and seconded for forming a work group on Marking and Labeling. Approved unanimously.

Motion made and seconded for forming a Drip and Micro-irrigation work group. Committee chose to Table this motion until the need arises from other committee work.

The Committee agreed that Scoping statements for the workgroups would be created at the next committee meeting after the Workgroups have convened at least once.

C. Other Business

1) Establish future meeting dates and times
