# 6.1 Cost impact (Attached)

Discussion:

- TG Chair Jonathan Humble went over history of the development of the Cost Impact Guide and thanked the TG for their efforts
- In support:

- This guide is a tool/guidance document that is coordinated with CP 28 requirements, not intended to revise CP 28 requirements
- Provides useful information to assist in the development of code changes
- In opposition:
  - This issue has been studied for decades. This is a public health issue.
  - o This is not a true consensus document
  - o A minority report was developed and distributed prior to the meeting
  - o Guide lacks economist review and societal impacts
  - O Such a guide should address both cost and benefit
  - o CP28 does not go far enough in its requirements for cost impact
  - o Some SDO's do not allow cost to be discussed in their proceedings

Motion passed to approve the document and forward to the Long Term Code Development Committee (LTCDP) along with the minority report

## 6.2 Ethics (tabled from "New Business" at October 19<sup>th</sup> meeting)

- 4 documents reviewed
  - o File "IAC Ethics 1 of 3"
  - o File "IAC Ethics 2 of 3"
  - o File "IAC Ethics 3 of 3"
  - o File "IAC 2009 Rec Changes to CP37 w/ Jake Paul's additions"
- Jeff Shapiro noted the history on this issue going as far back as 13 years ago. This proposal
  includes the reinstatement with revisions of CP 37 Ethics but also retains the current Code of
  Ethics
- Code of Ethics document is too vague/aspirational
- Disclosure/proprietary interest/conflict of interest must be addressed in ICC processes
- Comments from other IAC members have been built into the document
- This document was part of the basis for the LTCDP OGCV voter statement in CP28
- The issue of Ethics has been an issue for decades
- Earlier this year Ethics concerns have be voiced to the Code Council Board.
- There is a duty to report Ethics violations

- The update of the IECC has been removed from ICC's Governmental Consensus Process and now will be updated via ICC's Standards process and the "ICC Consensus Procedures"
- No decisions have been made on possible changes to the dates of the 2022 CAH due to the removal
  of the IECC from the hearing process

# 8.1 Board Committee on the Long-Term Code Development Process – Staff update (see website link)

- Staff provided an update on LTCDP activities
  - o CP 28 updated to require an OGCV voter statement sign off as part of the OGCV process (CP 28 Section 8.2)
  - o Federal Preemption and the I-Codes under discussion at the Board level
  - Possible process restructure to include 2 Committee Action Hearings for each cycle under discussion at the Board level
  - The LTCDP has initiated discussion on the Voting Majorities and the OGCV as they relate to code change proposals which are disapproved at both the CAH and the PCH. This was one of the items appealed in 2019 Group B
- Director Boso provided the following update
  - The Board decided previously to hold the 2021 PCH in person, with Covid protocols being implemented as directed by the CDC. The Annual Conference will be restructured/shortened by a day
  - o The Code Council is financially strong with a focus on customer service
  - o ICC's digital code offerings continue to be well-received

Rick Hauffe with GR provided an update:

- ICC held a panel discussion in West Palm Beach, FL on the Surfside condo collapse. Discussion limited to codes, inspections and building owners, not causation of the collapse as NIST in performing the investigation
- The IECC is being coined "The Code on a Mission" with a goal of 1/3 of the US on the IECC by the end of 2023
- Sara Yerkes, SVP of GR is retiring at the end of this year and will be replaced by Gabe Maser, Deputy SVP. Sara has been a huge asset to the Code Council and will be missed
