- a. D. Meyers, Proponent of REPI-146, motion to discuss REPI-146 after REPI-143 today. Demers motion. Schwarz second. Passes. No nays.

- a. Discuss REPI-143-21
 - 1. Proponent comments heard from R. Schwarz.
 - **2.** T. Culp (Glazing Industry) comment in favor with question about possible loophole in current as well as proposed language.
 - **3.** D. Meyers request clarification of low energy reference.
 - **4.** J. Zengel (Zengel Group) request clerical confirmation, discusses complexity of application, suggested initial and final blower door test as comparable determination of equal energy.
 - **5.** Proponent clarifies intent is to clarify process already in Code.
 - **6.** A. Martino comment in favor, requests clarification of possible confusing language, requests clarification of low energy space, requests multiple clarifications.
 - **7.** J. Zengel requests clarification.
 - a. J. Crandell (Chemistry Council) comment on history of unconditioned space provisions in Code.
 - b. Proponent clarifies 2 separate aspects of proposal: 1 is moving section on unconditioned spaces, 1 is providing new compliance clarification and process aspects.
 - c. J. Crandell comment in favor and on possible need for some clarification of confirmation of parity between compliance options.
 - d. Proponent clarified how proposal achieves intent via example of existing house with

addition.

- e. Further discussion between J. Crandell and Proponent.
- f. E. Hensely comments on need for Proponent to disclose membership on Committee.
- g. R. Schwarz discloses membership on Committee.
- h. S. Dent comment on concern about 30% exception, more comfortable with 300-500sf & concern about lack of specificity in upgrade exception.
- i. J. Phelan comment with concern over ERI pathway and its insufficiency at communicating energy use thus possibly not ensuring achievement of intent.
- j. Proponent response regarding how ERI is relevant though not as perfect as potential other methods, and states open to proposal of modification to meet comment of Committee.
- k. S. Denniston (NBI) comments on some problems regarding HVAC section.
- I. S. Wiley questions on need for 3 models, possibly 2 will be fine.
- m. Proponent comments on utility of 3 models to ensure results.
- n. S. Wiley questions 10 year energy efficiency exception.
- o. Proponent comments that 10 year comes from discussions with Colorado municipalities.
- p. E. Hensely questions 30% exception and requests addition of square footage cap as something like 600 squarefeet, and asks for qualification of energy efficiency upgrade.
- q. S. Dent recommends "meet or exceed" language.
- r. J. Crandell comments that proposal possibly decreases efficiency rather than its intent.
- s. A. Martino requests clarification of clerical.
- t. E. Henseley motion to table. S. Wiley second.
- Recommendations of Sub-Committee: 30% exception removal, adding squarefootage limit to 30%, ACCA carve-out removal, clarification of energy efficiency, clarification of addition needing to comply with Code by/in/of itself.
- Chair proposes scheduling re-hearing in March 8th meeting. 4 I's. Count of hands: 7 in favor. 1 hand against motion.

R402.1 General. The building thermal envelope shall comply with the requirements of Sections R402.1.1 through R402.1.5.

Exceptions:

- 1. The following low-energy buildings, or portions thereof, separated from the remainder of the building by building thermal envelope assemblies complying with this section shall be exempt from the building thermal envelope provisions of Section R402.
- 1.1. Those with a peak design rate of energy usage less than 3.4 Btu/h × ft2 (10.7 W/m2) or 1.0 watt/ft2 of floor area for space-conditioning purposes.
- 1.2. Those that do not contain conditioned space.
