- a. Discuss **RED1-264-22**.
- 1. Proponent Chawla comments on history of development of proposal. Comments on definitions, compliance sections, and other elements of proposal. Comments on others involved on developing proposal.
- 2. Crandell comments & questions. Concern with definitions. Requests to keep Addition, Repair, and Alteration as is. States that Existing Building definition is helpful. Questions Existing Structure is that definition from elsewhere?
- 3. Chawla responds Martino best to respond.
- 4. Martino responds with general comments on proposal development and specific aspects of proposal.
- 5. Wiley comments on definitions and that Changes in Space Conditioning should comply with R502, not R503 as in proposal.
- 6. Kochkin comments that Compliance section may need additional wording. Adding the wording "the provisions...to this code" should be added to proposed section R501.2.
- 7. Chawla responds that is a friendly amendment.
- 8. Denniston comments that there are some weakening elements. "Replacement" should be removed from Repair definition. Unconditioned Space should be subject to applicable requirements of this Code and/or Additions but not only Alterations change R503 reference to R502. Does not support proposal in its current form and hopes it is edited.
- 9. Crandell comments that definitions need work especially regarding removal of "replacement" from Repair. Comments that Alteration should remain as is. Does not support in its current form.

- 10. Martino responds on friendly amendments: Changes in Space Conditioning would be acceptable to refer to R502 rather than R503. Regarding definitions argues to keep proposal definitions as proposed. Repair definition would be acceptable to refer to replacement fenestration 503.1.1.1.
- 11. Cain comments definitions do not need to match existing building code. Existing buildings definition is good to add to this code. Existing structure definition does not belong in this code. Suggests removing "existing structure" from other definitions. Suggests that other codes referred to in Compliance need not be there because it's required already. Does not support in its current form.
- 12. Denniston comments regarding Alteration section and compliance as well as other problematic aspects of proposal. Does not support or needs to be reworked.
- 13. Crandell comments regarding differences between renovations and retrofits within definitions. Get rid of existing structure.
- 14. Johnson comments on existing building definition that it would be good to be improved.
- 15. Wiley motions call to question. Demurs second. Unanimous support.
- 16. Wiley motions to table to final Subcommittee meeting so that working group can make friendly amendments as discussed. Second Demurs. Unanimous support.

b. Discuss **RED1-267-22**.

- 1. Proponent DeBarbero comments on experience with existing buildings and their challenges. Comments that rework of R503.1.1.2 is useful for real conditions and to clarify code. Comments that added R503.1.1.3 would be helpful to practitioners stopping by-passes would be good and in line with intent of code. Makes further comments on other aspects of proposal and explains proposal item by item. Overall intent is to improve code in-line with its understood intent but make it more useful and applicable to real conditions found.
- 2. Crandell thanks proponent and comments that there are good and problematic aspects of proposal. Various items addressed: R503.1.1.2 is not needed, its item 1 may be better addressed in RED1-268, possibly R806 reference would be better regarding vapor control, attic leakage portions may need to be reworked, "or approved design" is important to be retained, that floor edits may be an over-reach. RED1-268 addresses many of the important items in this proposal.
- 3. Denniston comments in agreement with Crandell and thanks proponent. Comments on concern with over-reach of proposal.
- 4. Proponent responds to various comments.
- 5. Wiley comments that certain ideas within the proposal may be very good to bring back to future proposal opportunities.
- 6. Proponent responds to various comments and comments that would like to bring forward reworked proposal.
- 7. Staff comments / responds to proponent that bringing back re-worked proposal in this cycle would need to be via Subcommittee proposal.
- 8. Zengel motions to disapproved. Wiley seconds. Unanimous support. Reason statement: code language is confusing in some passages and some code language conflicts.

c. Discuss **RED1-268-22**.

- 1. Proponent Crandell comments that intent is to coordinate and correlate Residential with Commercial. Comments on distributed proposal Modification that improves Re-roofing and to coordinate use of "approved source".
- 2. Johnson comments on "an approved design that minimizes deviation" that it is meant to convey "make it as good as you can" that it is so the code official can make a call based on site conditions.

- 3. Phillips comments thanks to Crandell and Johnson and comments on additional modification 503.1.1.2 that Roof, ceiling, and attic that the word "roof" should be removed from the beginning of the code text.
- 4. Crandell comments in agreement with Phillips. Requests to make that modification in the Modification document which was distributed.
- 5. Vice Chair Hansely makes that strike-through on the screen.
- 6. Cain comments on "approved source" that it should be improved rather than struck out. Comments that "approved third party" may be the best. Comments to Stenger (Staff) that possibly should be addressed by higher level ICC Committee such as a Steering Committee.
- 7. Zengel question to Crandell on re-roofing and commercial consistency if it is for the purposes of consistency, should definitions per RED1-264 be made consistent with IEBC?
- 8. Crandell responds that it is case-sensitive to improve the code so not necessarily needing to be consistent in every aspect. "Approved source" is proposed to be struck because it has structural implications and needs work in building code as well. Agrees with Cain comments.
- 9. Demurs motion to approve proposal with Modification and on-screen modifications. Swope seconds. Unanimous support. Reason statement: clarifies several section of code and fits appropriately in the IECC standard.
- d. Discuss RED1-269-22.
- 1. Proponent Phillips recommends disapproval based on RED1-268 action.
- 2. Zengel motion to disapprove. Wiley seconds. Unanimous support. Reason statement: Motion is in-line with the proponent's recommendation and previous Subcommittee discussion in this meeting.
- e. Discuss RED1-278-22.
- 1. Proponent DeBarbero comments generally.
- 2. Crandell recommends this proponent be tabled to be heard with RED1-264.
