- a. Discuss RE2D-06-23
- **1.** Proponent Crandell presents proposal. Clarifies that proposal could be considered errata because the proposal corrects Draft energy code to match with current Committee action.
- **2.** Phillips comments in support of proposal and comments in confirmation of the proposal correcting Draft to current Committee action
- 3. Wiley comment in support of proposal and of Phillips comments.
- **4.** Wiley makes motion to approve. Brown second. Vote unanimous to approve. Motion passes. Reason statement: Proposal addresses a clerical error in the Draft Code and restores what has been currently approved by the Committee and so should be in this Draft Code.

b. Discuss RE2D-07-23

- **1.** Proponent Johnson presents proposal. Johnson explains that some existing buildings do not have a permit.
- **2.** Cain comments not in support of proposal. Comments that final inspection and certificate of occupancy make something an existing building. Comments that there is a problem with the current definition.
- **3.** Martino comments in support of Cain. Comments that Wiley brought in this definition language from IEBC. Comments not in support of proposal.
- **4.** Wiley comments in support of previous comments and suggests adding verbiage such as "recognized by the local municipality" to improve the existing definition, not proposal language.
- **5.** Martino suggests removing definition from Code.

- **6.** Johnson supports Martino suggestion.
- **7.** Smith suggests that without definition in this Code then this Code will defacto point to other Codes.
- **8.** Rosmiller confirms Smith's understanding of the Code.
- **9.** Martino comments that this definition is in the Code currently but cannot find the citation.
- 10. Cain comments not in favor of removing definition and leaving consistent language.
- **11.** Johnson comments that, given a word search of the Code, most uses in Code are not of "existing building" but are "building".
- **12.** Hensley makes motion to disapprove. Brown seconds. Wiley suggests modifying current definition as suggested in previous comments. Rossmiller clarifies to Wiley that modifying language would require overturning current Motion. Votes 4 in favor, 1 against. Motion passes. Reason statement: Existing definition in Code is sufficient.
- c. Discuss **RE2D-08-23**
- **1.** Proponent Johnson presents that the proposal clarifies the definition and its intent.
- **2.** Cain comments that consistency between Codes is important. Comments that "ordered" could be replaced by "identified", but does not make proposal to modify proposal.
- **3.** Henlsey makes motion to approve. Swope seconds. Vote unanimous in favor. Motion passes. Reason statement: Proposal adds clarity to the Code because the current language linguistically states that the Code Official is ordering violations which is not the case; so the Proposal corrects language in the Code and clarifies the intent of the Code.
