8. Construction Cost & Life Cycle Cost Temporary Advisory Group report.

Michael Tillou, chair of the advisory group, provided an update on the work of the advisory group to this point. The group will look at using two approaches. First being a Life Cycle Cost approach using the Scalar method similar to that currently used by ASHRAE. The second method would use a "constant dollar" approach championed by Charles Eley. Both approaches would also consider the benefit of the social cost of carbon and other externalities but must be done in parallel to cost effectiveness using only first cost and energy cost savings. Items still to be considered in this area include economic factors such as discount rate and fuel escalation, when this approach is applied, and analysis criteria for externalities. Also, there will be consideration as to whether public and private buildings need separate approaches. A spreadsheet has been developed by Charles Eley that may be the model for this approach.
