 - CEPI-220-21. Proponent SEHPCAC represented by David Collins. Motion by Emily Lorenz to Approve. Second by Greg Johnson. Motion passes 39-0 chair not voting.
 - 2) CEPI-2-21. Proponent Darren Meyers. Motion to disapprove by Hope Medina. Second by Emily Lorenz. Motion passes 35-4 with 1 abstention. Reason: the term "process energy" is not used in the code terminology, the exemption is already covered under C402.1.1, and the definition "process energy" might be confused with current terminology "process load" used in the IECC
 - 3) CEPI-1-21. Proponent Darren Meyers. Motion by Hope Medina to send proposal for review by Envelope Subcommittee with additional review by the Electrical Subcommittee. Second by Shaunna Mozingo. Motion passes 31-4 with 1 abstention.
 - 4) CEPI-3-21. Proponent Darren Meyers. Motion by Hope Medina to disapprove. Second by Scott Brooks. Motion passes 29-8. Reason: the provisions of the thermal envelope should remain if this space is to be heated or cooled.
