1. Call to order by Vice Chair Emily Hoffman. The meeting was called to order at approx. 2:01 pm Eastern Time.

- 3. Approval of the Minutes from July 12-motion to approve by Richard Burton with a second from John Dalzell. Approved unopposed.
- 4. Approval of Agenda-motion to table proposals CE2D-33-23, CE2D-34-23, CE2D-29-23 to be heard with other metering proposals until the August 30 meeting by Michael Tillou. Second from Emily Lorenz. Motion to table passes 29-0-1. Motion to approve modified agenda by Payam Bozorgchami with a second from Greg Johnson. Approved unopposed.
- 5. Administrative items-none at this time.
- 6. Action Items-

- a) CE2D-17-23(Table C403.3.2(12) footnote edit) Proponent Greg Johnson. Introduction by Blake Shelide vice chair of HVACR & water heating subcommittee. Motion to approve. Motion to approve passes 28-0. Reason: Footnote should not contain requirements. The purpose of the tables are to identify 'minimum efficiency,' so it does not need to be repeated in the footnote.
- b) CE2D-19-23(Boilers footnote i edit) Proponent Greg Johnson. Introduction by Blake Shelide vice chair of HVACR & water heating subcommittee. Motion to approve as modified. Motion to approve as modified passes 30-0. Reason: this footnote isn't applicable anymore since it is for older equipment.
- c) CE2D-22-23(Demand responsive controls) Proponent Greg Johnson. Introduction by Blake Shelide vice chair of HVACR & water heating subcommittee. Motion to approve. Motion to approve fails 9-21-1. Motion to disapprove by Dan Nall with a second from John Dalzell. Motion to disapprove passes 22-8-0. Reason: Demand response measures in R2 occupancies have been demonstrated to be effective for improving grid stability and reducing energy costs.
- d) CE2D-23-23(Demand control ventilation exception 6 edit) Proponent Greg Johnson. Introduction by Blake Shelide vice chair of HVACR & water heating subcommittee. Motion to approve with a modification to retain "demonstrates" and remove "provides". Motion to approve as modified passes 29-0. Reason: editorial.
- e) CE2D-26-23(C404.2 table footnote L edits) Proponent Greg Johnson. Introduction by Blake Shelide vice chair of HVACR & water heating subcommittee. Motion to approve. Motion to approve passes 30-0. Reason: editorial.
- f) CE2D-6-23(Green retail tariff definition) Proponent Greg Johnson. Introduction by Greg Eades chair of Modeling subcommittee. Motion to disapprove. Motion to disapprove passes 22-7-1. Reason: This proposal would replace the definition of "renewable energy resources" (a defined term) with "renewable energy" an undefined term.
- g) CE2D-58-23(Remove limit on use of surplus credits for renewable) Proponent Jay Crandell. Introduction by Greg Eades chair of Modeling subcommittee. Motion to approve. Motion to approve passes 27-3. Reason: This proposal removes the 30% limitation on renewable and load management credits. Removing the 30% limitation provides flexibility in achieving credit compliance, and a clear rationale was not presented for the 30% reduction.
- h) CE2D-1-23(Appendices) Proponent Eric Tate. Introduction by Greg Johnson vice chair of Administration subcommittee. Motion to disapprove. Motion to disapprove passes 27-0-1. Reason: It is important to notify the user of the code in Chapter 1 that the appendices are mandatory only when adopted by the AHJ.
- i) CE2D-2-23(Substantial improvement definition) Proponent Greg Johnson. Introduction by Greg Johnson vice chair of Administration subcommittee. Motion to approve. Motion to approve passes 28-0. Reason: The proponent is correct that the existing sentence structure implies the code official may have ordered the violations.
- j) CE2D-10-23(SEHPCAC/BCAC accessible term replacement) Proponent SEHPCAC. Introduction by Greg Johnson vice chair of Administration subcommittee. Motion to approve. Motion to approve passes 28-0. Reason: the word "accessible" should remain reserved for uses associated with accessibility requirements for disabled persons as suggested by the proponent.
- k) CE2D-69-23(C503.2.1 defined term correction) Proponent Glen Clapper. Introduction by Greg Johnson vice chair of Administration subcommittee. Motion to approve. Motion to approve passes 25-1-1. Reason: revising the terminology used provides consistency with residential code.
