6. Administrative issues. Held to action item discussion.

7. Action Items

- a) DOE/PNNL Interim analysis on IECC-R Public Input proposals. Rob Salcido led the presentation of the DOE/PNNL interim analysis of the IECC-R Public input proposals. Mr. Salcido first went through the methodology of the analysis before providing a summary of the results. On average the net energy savings of the approved IECC-C Public Input proposals is roughly 8% compared to the 2021 IECC-C. 30 proposals in the Public Input draft had impact on the prescriptive requirements and of those 8 were able to be modeled in the progress indicator. The presentation concluded looking at the benefits of the approved readiness provisions. There was discussion related to quantifying carbonization, glide path, and cost effectiveness.
- b) Administrative procedures. Mike Pfeiffer led a discussion on the IECC procedures use of Robert's Rules of Order. Items discussed included

Staff continued with voting procedures in this next step as subcommittees require a majority vote for a recommendation while actions of the Consensus committee require a 2/3 majority. Following voting staff reiterated that only substantive changes to the Public Comment Draft #1 will be open for comment on Public Comment Draft #2.

- a. Staff reviewed totals and initial subcommittee assignments of the code changes/public comments submitted during the public comment period for the Public Comment Draft #1. Staff anticipates the monograph of code changes/public comments to be posted prior to the holiday. Staff provided the subcommittee and consensus committee proposed schedule with an anticipated completion date at the end of April.
