C. has been honored to be appointed to the ICC Board of Directors to serve as the Section F Director in July 2024, to complete the unexpired term of a vacated ICC BOD seat.

Mr. Hudgison is the current Construction Services Center Manager/ Chief Building Official for the City of Tampa, FL. He has more than 15 years of experience in the fields of architecture, building codes, construction, and construction management. J.C. has received his Certified Building Official (CBO) certification from the International Code Council (ICC), is an associate member of the American Institute of Architects (AIA) and is a licensed Building Code Administrator through the State of Florida Department of Business and Professional Regulation (DBPR). Most recently in 2020, JC has become the Construction Services manager and chief building Official for the City of Tampa, Florida. Before this appointment, he

served as the Director of Building Inspections and Code Enforcement where he directed the plan review and inspections program relative to the construction as well as Property Maintenance and Special Enforcement Divisions.

JC works well with individuals and with groups to understand issues fully and works to develop programs and policies to achieve the best outcome for all involved.
