Chair Hensley moved forward with discussing Duct topics beginning with IRC EPI 3.21, tweaking definition and discuss the code change it is attached to. The group agreed to the changes made to the definition and to put on hold – no voting took place.

Chair moved to discuss Section 1101.6 for Duct Airflow Balancing. After discussion the Chair proposed to build small work group to refine. Volunteers for the workgroup to discuss 1101.6 are Chris Perry, David Bixby, Don Thomas, Dwight "Sonny" Richardson, Gary Klien.

Next proposal offered by David Bixby was IRC EPI 6.21, the group discussed adding Manual D to the requirements. Discussion of definition change with minor changes was agreed by the group.

Next proposal offered by Steve Rosenstock was IRC REPI 072.21, David Bixby mentioned ACCA is updating standard and to verify with the manual and investigate further that all is covered. Wait for proponents to be present.

Discussion for REPI 1.73.21. Group discussed and attachments were included in the proposal. Heat pump proposals will be on January 17<sup>th</sup> meeting along with Ducts.
