WHEREAS, the Members of the International Code Council did assemble at the Code Council's 21st Annual Conference in Long Beach, California from October 20 to October 23, 2024; and

WHEREAS, the International Code Council is celebrating its 30th anniversary of bringing together building safety professionals from around the world; and

WHEREAS, the International Code Council has evolved over its 30 years in creating model codes and standards and building safety solutions used to ensure safe, affordable and sustainable communities and buildings worldwide, and

WHEREAS, the International Code Council Family of Solutions has expanded to cover such items as accreditation, evaluation services, materials testing and tools to provide for resilient communities, and

WHEREAS, the International Code Council has expanded significantly since inception to include professionals from all disciplines involved in building, regulation, design, and construction, requiring the development of strategies and policies that reflect its increasingly diverse membership, and

WHEREAS, the Bylaws of the International Code Council allow only Governmental Member Voting Representatives (with the exception of the Immediate Past President) to serve on the Board of Directors, and

WHEREAS, several ICC Chapters provide for their Board of Directors to include other members such as public members, and

WHEREAS, Item #4 of the Vision 2025 Strategic Plan, Assess the organizational structure, states "the complexity of the Code Council's business model may require changes to the governance, operational and management structures to allow for sustainable growth and operational excellence", and

WHEREAS, State licensing boards along with Professional organizations such as the National Council of Architectural Registration Boards (NCARB), and the Council for Interior Design Qualification (CIDQ) require a diversity within their board membership structure, including public members; now therefore,
