613.4.1 some of the language is not enforceable. #3 and 5. If #1 is in 614.4.5, it is already addressed there. #8 need editorial clean up.
The requirements listed are to the for the entire system, not just the changing surface (613.4.1)
Modification to delete Section 613.4.1 26-3-0

- 04-12 – AS (5-18-3) D (23-1-1)
Notes: interior okay, need to address loads, but need specific from the door industry for loading
- **04-13 – hold till June 2 per Mike Tierney**
- 04-14 – errata
Notes: this is a signage issue, not a side lite issue – could be addressed with better lighting, options for placement (especially in corridors with doors in recesses), education on signage for persons with low vision, clarification on placement of clear floor space in front of sign.

- 04-15
Notes: text needs to add gates because that is what this section covers; conflict with existing 404.3.8 for hardware; A156.19 is already addressed in 404.3, so this does not add anything
Mod to add swinging (25-1-0); AM (13-7-3)

Note: conflict with existing 404.3.8 for hardware; standards are already addressed in 404.3, how to you push or pull open automatic doors; what are the forces; what happens to gates?
