Divide question:

- 604 AS 5-22-2/D 24-6-2
- 607 AS 7-18-4/Motion to Disapprove; Motion to table 17-9-2 till 8/25/2022 call; Motion to untable passed; Motion to table part 2 to end of chapter 6 carries with 3 votes in opposition.
- 608 Motion to table parts 3 to end of chapter 6 carries with 1 vote in opposition
- 609 Motion to table parts 4 to end of chapter 6 carries with 1 vote in opposition
- 2) Presentation of Reach over counter work group replacement for 11-20, 11-21, 11-22 Dan Buuck presented the report and discussion about the Type B outlets. Explained the Task Group's thinking and dealing with where permitted vs. where they are prohibited.

Two option: Install less than 44 inches above the floor (no reach range or clear floor space requirement), or comply with the item 12 to get the clear floor space and reach range. Would not need to worry about appliances projecting past counters. Setting a height of 44 inches seemed to be the easiest way to permit standard 36 inch counter with 4 inch backsplash and so setting the 44 inch was a trade off versus reach range and clear floor space.

Exception 2 and 3 deleted since it caused confusion. Again the task group felt that the 44 inch solved this. This could result in outlets being located above the intersection of corners, and not really reachable, but again the idea is to address where they are allowed versus where they are prohibited. Would like more information and details or ideas to address redundant controls. This option would NOT require a 30 x 48 inch clear floor space in front of each outlet. Also not going worry about issue of appliances like refrigerators projecting out beyond counters.
