#### 1. Call to Order- Chair Bland

In Chair Bland's absence, Ron Burton called the meeting to order at 12:05 P.M.

#### 5. IAC Administration

#### 5.1 Chair's Report

Ron Burton read Ken Bland's remarks, thanking the IAC for their participation and support during his chairmanship. Of note:

- The new plan to streamline communication between the IAC and the ICC Board
- IAC Executive Committee met with the members of the ICC staff senior management team in May.

### 5.2 Report of the IAC Nomination Committee

a. Election of 2011/2012 IAC Chair and Vice Chair

#### 6.1 National

David Karmol reported that the ICC Code Grant bill can't get out of the Senate committee. DOE issued a determination of the 2003, 2006 and 2009 IECC - each more efficient than the preceding editions. He also reported that OSHA allowed the IFC to be a 'deemed to comply' under 1910 subpart E means of egress. Chair Burton asked if anyone else had any Federal activities that they wanted to report. Julie Ruth commented on EPACT.

#### 7. IAC Activities

#### 7.1 Task Group - Temporary Interim Amendments (TIA) Process

Marshall Klein described the process. He noted that the new 3 year code process may necessitate a vehicle to update the code via a TIA process for important issues. A motion to approve the report was withdrawn as

this was the first time the IAC has seen it. Motion to send the revised TIA process to the IAC for a vote via ballot was approved.

#### 7.2 Task Group – Code Hearing Advocacy Issues

Ron Burton said that there was nothing to report - the TG needs to meet to discuss.

#### 8. ICC Codes & Standards Activities

#### 8.1 2010 Final Action Hearings

Mike Pfeiffer reported on the Dallas Hearings, indicating that 75% of the codes were considered in the amended Group A. He added that the Code Development Hearings will be at that same hotel for the next 3 years. The Charlotte Hearing schedule has been posted - October 25<sup>th</sup> will have the Administration and Zoning Hearings followed by Energy, starting Wednesday. The objective is to be done no later than noon on Sunday.

Ron Burton raised the issue of outside funding for travel to the Final Action Hearings. Mike Pfeiffer responded that attendees must self-certify compliance with CP #36. Craig Conner expressed his concern on the issue, seeking upgraded rules to separate funding from voting. A handout from Craig was distributed at the meeting. Discussion:

- Process influenced by funding
- ICC should publish a list of those who received funding and who provided the funding
- It is o.k to provide funding for educational training; not to travel to the hearings and vote

There was further discussion regarding the actions of various groups providing funds to attend in an effort to affect voting. Dominic Sims pointed out that the penalty for violating the rules is possible loss of voting privileges. Jimmy Brothers added that, 'Integrity is the over arching value proposition.' Craig Conner suggested that ICC should state publicly sponsorships of 10 or more.

A motion was made and seconded that IAC issue a statement of concern with travel assistance and that a list of organizations which funded 10 or more be publicized. Motion failed. A motion was made and seconded that ICC reach out to groups who are offering travel funding and remind them of the policy. Motion passed.

#### a. ICC Foundation - Code of Honor Scholarship

Leslie Chapman-Henderson presented the Foundation Scholarship program to assist those who may not otherwise be able to attend. Of note was the 29 scholarships for Dallas and 34 slated for Charlotte.

It was moved to support the Code of Honor Scholarship program. The motion passed.

The letter by the ABC was distributed. It was noted that the content was previously published as a comment to PV 1.0 (G1-1) of the IGCC and heard at the 2010 IGCC Public Comment Hearing. The letter and comment express concern about the mandatory nature of the IGCC. Discussion:

- Cost to implement
- NAHB policy is opposition to mandatory compliance
- IGCC provides consistency in lieu of each jurisdiction deciding what to enforce

• IGCC provides flexibility via project electives and jurisdictional options

No action was taken.
