5. **IAC Administration**

5.1 Chair's Report

Jeff thanked the group for allowing him to serve as chair the past two years. He noted some of the issues addressed by the IAC, namely:

- Interim Critical Amendments to the codes

Jeff encouraged more participation from IAC members, noting that we typically have about 1/3 of the IAC members participating in the semi-annual meetings.

6. IAC Activities

Staff updates: 6.1

a. Referenced Standards Task Group

At the April/2018 Board meeting held in conjunction with the 2018 Committee Action Hearing, the ICC Board considered the IAC recommendation for revising the standards update process. IAC members Jeff Hugo and John Catlett where in attendance. The Board did not approve the proposed revisions, citing the current process is adequate.

The IAC voted to disband the task group.

b. Cycle and Code Grouping Task Group

Staff indicated that the Board will be initiating the review of code development long term feedback and noted that the Board is aware of IAC's request to be a participant in the process.

6.2 Temporary Interim Amendments (now called Interim Critical Amendments): Version 5.1 Discussion:

- Codes and Standards Council (CSC) originally not in favor of earlier versions but supports the current version
- CSC suggests the revision noted on Version 5.1 in Section 2.4.2.11 which deals with ICA's becoming an automatic code change with the CSC as the proponent.

IAC motion to approve the revised language for Section 2.4.2.11 passed.

IAC approved version 5.1 As Modified and directed staff to submit to the Board.
