

## SIXTH COMMITTEE MEETING MINUTES Off-Site Construction Mechanical, Electrical and Plumbing Standard Consensus Committee (IS-OSMEP)

The sixth meeting of the ICC Off-Site Construction Mechanical, Electrical and Plumbing Standard Consensus Committee (IS-OSMEP) was convened on May 4, 2022 to continue the process of developing the ICC 1210 standard. The teleconference meeting was conducted through Webex.

- 1. Meeting Opening
  - a. Opening remarks, objective of the meeting, and housekeeping:
