

## SECOND COMMITTEE MEETING MINUTES Off-Site Construction Tiny Houses Standard Consensus Committee

The second meeting of the ICC Off-Site Construction Tiny Houses Standard Consensus Committee (IS-OSMTH) was convened on February 21, 2024 to continue the process of developing the ICC 1215 standard. The teleconference meeting was conducted through Teams.

- 1. Meeting Opening
  - a. Opening remarks, objective of the meeting, and housekeeping:

Director of Standards and Staff Secretariat, Karl Aittaniemi called the meeting to order at 2:02 pm CT and welcomed all committee members and ICC staff. This second meeting of the committee is open to the public in accordance with ICC policy.
