#### **Activities Completed Since Last Annual Meeting:**

- The ELMC Advisory Council edited and submitted the Charter for the creation of the ELMC. Charter was approved May 11, 2017, by the ICC Board of Directors.
- Mike Tomaselli authored the first report on the ELMC's assessment of cdpACCESS for submission to the ICC Board of Directors summer meeting.
- The Advisory Council, at its meeting in Arlington, Texas, formed task groups based on the five focus objectives outlined in the ELMC Charter to develop initial goals and project plans for the new ELMC Governing Committee:
  - Develop programs and capitalize on opportunities to promote new and emerging code professionals and to expand interest in code careers among young adults.
  - Identify and pursue funding opportunities available from federal, state and local grant programs for the purpose of expanding career development opportunities for young code professionals.
  - Encourage new and emerging professionals to advocate adoption of the International Codes at the local, state or federal level and to seek opportunities to advance their participation in code development and adoptions.
  - Advocate new resources from ICC and code advocacy organizations to offer a greater variety of robust training, education, and certification programs that prepare new and emerging professionals to develop their careers and enter

- positions of leadership among ICC Chapters, local and state governance and stake holders within America's built environment.
- Provide leadership in the development and use of innovative technologies and various effective social media to improve efficiency and enhance ICC's ability to attract and communicate with people who would benefit from code careers and involvement in ICC.
- Individual task group leaders started prioritizing goals established by the Advisory Council.
- Two news stories featuring Advisory Council members were published in the Building Safety Journal (April and June editions) to promote the ELMC and the 2017 Building Safety Month.
- The Advisory Council, assisted by ICC staff, created the ELMC webpage on the ICC website as well as an ELMC Facebook page and a Twitter account. The ELMC webpage was constructed to provide updates on the ELMC governance, to focus on ELMC members' careers and ICC activities, to promote membership and activism in the ELMC and the ICC, and to provide relevant news information.

## Anticipated Activities for Upcoming Year(s):

- 1. Membership recruitment drives
- 2. Partnering with the Building Official Membership Council "Raising the Profile" Task Group to provide the ELMC's opinion and recommendations make the task group's work more effective with new generation code officials.
- 3. Partnering with the BOMC's "Preparing for the Future" Task Group.
- 4. Working with the BOMC and the Fire Service Membership Council to develop training programs aimed at young code professionals and enhancing management opportunities.
- 5. Developing relationships with the ICC High School Technical Training Program and other stake holder efforts aimed at inspiring interest in code careers among young people.
- 6. Capitalizing on ICC's network of local, state and regional Chapters, Code Action Committees and other stake holders to promote interest and Membership in the ELMC and its activities.
- 7. Use the structure of the five Focus objectives to expand active involvement among ELMC Members beyond the five ELMC Governing Committee Members selected to lead each of the five objectives.
