    - i. Chapter Update Report sent out by Dave Nichols included an important notice regarding ICC governmental member voting representatives (GMVRs). - vii. Adolf Zubia asked about the survey that went out about online voting What is the background and likelihood of success? Angie: Technology is there today to do live voting for board members. The ICC board thought the membership should weigh in on its concerns particularly with regard to equal representation. ICC President Bill Bryant is extremely interested in pursuing the nuts and bolts of an online voting system and associated policy.

  - i. Collaborating with Chief West, Chief Metz, and Dave Nichols on ways to increase participation on the FSMC monthly calls.

  - e. Work Group/Committee Discussion- Goals 2019
    - i. Training and Education (Gerczynski)
      - 1. Spoke with Fulton by phone for background, mission, and direction. Also spoke with Karl. We have a block at the ABM. We're late with our submission but we're working on keeping the block. Fulton had Greg Castle lined up to do a presentation on the October 1 shooting event. Maybe a 90-minute talk about fire safety at construction sites would be in order? Feedback from the Governing Committee generally supported the idea of a 90-minute class rather than the shooting event.

2. Angie Wiese asked if Clark County could adapt their presentation so it applied to the built environment. Fulton Cochran replied that fire marshals and other code officials have to approve special event permits, so this might be applicable. Jeff Shapiro indicated that this might make for a good panel discussion regarding the changing role of fire prevention. Chief West suggested that the committee handle this discussion. Chief King offered a motion for the Training and Education Committee to move forward with pursuing a panel discussion to include the Las Vegas shooting event and its place in the changing environment of fire prevention. Motion seconded by Kelly Nicolello. Motion passed by unanimous vote.

### ii. Membership Outreach (King)

1. Chief West called. This is currently a committee of 1. Chief King is looking inside and outside of the governing committee and has lots of work to be done. This is a quick summary of the call for purposes of our time today. Looking for volunteers.

- 4. We'll be working to post more information on our FSMC web page to hopefully increase our readership, interest in what we do, what information we have, etc. For example, working collaboratively with the membership committee developing twitter messages and other outreach and communications.
