 - a. Work Group Assignments and Goals General discussion by members regarding the current staffing of FSMC work groups. The FSMC Public Awareness Work Group submitted proposed changes to the Code Council in Fall 2021. Originally those changes were to be incorporated by February 2022. Karl will follow up with ICC staff to get an update.
- d. Building Safety Month Video Brainstorming
 Group discussed possible ideas for BSM Video with Sustainability Membership Council.

e. Other items

Training and education discussion - video course for new inspectors (example Certified Fire Investigator training video from IAAI). Suggestion made that FSMC could rotate governing committee representatives to produce short, quick hit videos for prevention monthly.

Discussed subcommittee logistics for review of Innovation in Code Administration Award nominees. More to come once award nominations are closed on April 15.

Members discussed concern regarding trip to Rochester only to have a single 2-hour time slot. Members would prefer a full workday and a half, particularly for folks traveling in from opposite coasts. Members emphasized that FSMC meets every month and that the group needs face to face work session time. Group understands these meetings are a big commitment of dollars and resources for ICC, members and the ICC should get more out of them.

Decided to carry forward the Continuity and Outreach discussion and report out on work group realignment for Sunday session with full governing committee.
