D. Additional New Issues for possible consideration as Work Items

- 1. From PMGCAC members Tomberlin: Clarify language of IPC 403.1.1. Already on working document as Item 19 as this was decided last meeting.
- 2. From ICC Staff members None brought forth at this meeting
- 3. From Interested Parties- Kevin Kalakay: IMC Section 402 Natural ventilation provisions could be updated like ASHRAE 62.1-2022 edition offers. Add to Working document. Added as Item #20.

E. Technical Discussion of Items from Last Cycle that were not successful.

<u>Working Document Item #4:</u> IMC exhaust and air intake termination access. M17-2-- Report of hearing committee reason is brief. Spacing of louvers was an issue. Need to review hearing video (send out to group.) "Dwelling unit" term may raise flag as might be related to single family dwelling? Existing section doesn't address <u>exhaust</u> terminations; only air intake.

<u>Working Document Item #1</u>: Reorganization of IMC plenums section. M55-21–Dropped as M55 passed last cycle-No further action

Working Document Item #5: IMC Plant processing and extraction facility ventilation. M27-21—Working document #5. Does this belong in IMC or in Chapter 39 of the IFC. Section 408.2 was needed by FCAC however, the IMC doesn't retroactively apply. That should be covered by IEBC. IMC should own these requirements with IFC pointing to it? FCAC, BCAC and PMGCAC are generally on same page. A working group (WG#3) is established. Chair Andrew Bevis, Vice Chair Kevin Brenton.

F. Technical Discussion of New Items

<u>Working Document Item #6</u>: IPC Commercial pool plumbing fixture calculation. – Generally, code officials are taking the pool occupancy and the deck occupancy and combining to apply to the fixture. Result is too many fixtures. Need a working group (WG#4). Chair-Ken Gregory, Vice Chair? (Rich Anderson, an ICC staff member, was mentioned but he is not a CAC member.) John Taecker as interested party.

Working Document Item #7: IMC Table 403.3.1.1 — category description needs clarified.— There are a variety of configurations to think about. Gress says the intent was to not have ventilation required for a single vehicle garage. Otherwise, ventilation is needed. Is there a definition of an enclosed parking garage. No. (Is it the opposite of an open parking garage?) Could something be put into the footnote about a single vehicle garage exempt from ventilation? Maybe put in new footnote "i"? What problem are we trying to solve? Re-visit after folks have some more time to think about.

Working Document Item #8a: IPC Pipe labeling for nonpotable water systems -- Working Document "Second" Item 8 (renumbered to 8a). Section 608.9.2 already spells out nonpotable water distribution piping. Is marking 25 feet is too far apart? Is the wording in Section 608.9.2 just missing "distribution"? What about chilled water blow down piping; should not that be covered in this section-it's not a distribution system.
